Unseen passage

A great deal has been said about the duty of the artist to society. It is argued that the poet, the novelist, the painter, the musician, has a duty to the community; he is a citizen like everyone

else; he must pull his weight, he must not give himself airs or ask for special terms, he must pay his taxes honoyrably, and keep the laws which have been made for the general good.
